

#### **GUIDELINES FOR STALL HOLDERS**

- I. The Organizing Committee will provide the basic shell of each stall, electricity, stan dard signage, and seating.
- **II.** Additional facilities such as extra furniture, internet and broadband services, special electrical connections, special lighting and audio- visual equipment, and additional manpower will be arranged by the event manager on extra payment. Contact details of the Event Manager may be requested. Payments for all additional facilities have to be made in Advance and before the commencement of the Exhibition.
- **III.** An Exhibition service Centre will function from 10.00 am on Conference day 20th November 2025, for the duration of the Exhibition. The Event Manager and his representative will assist with all requests and emergencies to the best of their ability.
- **IV.** All such temporary workers will have to leave the venue of the conference when the exhibition begins at 11:00 am on the conference date 19th November 2025.
